the factor that makes some communities rebound quickly from disasters while others fall apart a fascinating book on an important topic e l hirsch in choice each year natural disasters threaten the strength and stability of communities worldwide yet responses to the challenges of recovery vary greatly and in ways that aren t explained by the magnitude of the catastrophe or the amount of aid provided by national governments or the international community the difference between resilience and disrepair as daniel p aldrich shows lies in the depth of communities social capital building resilience highlights the critical role of social capital in the ability of a community to withstand disaster and rebuild both the infrastructure and the ties that are at the foundation of any community aldrich examines the post disaster responses of four distinct communities tokyo following the 1923 earthquake kobe after the 1995 earthquake tamil nadu after the 2004 indian ocean tsunami and new orleans post katrina and finds that those with robust social networks were better able to coordinate recovery in addition to quickly disseminating information and financial and physical assistance communities with an abundance of social capital were able to minimize the migration of people and valuable resources out of the area with governments increasingly overstretched and natural disasters likely to increase in frequency and intensity a thorough understanding of what contributes to efficient reconstruction is more important than ever building resilience underscores a critical component of an effective response

there are at least four reasons why a sleep clinician should be familiar with rating scales that evaluate different facets of sleep first the use of scales facilitates a quick and accurate assessment of a complex clinical problem in three or four minutes the time to review ten standard scales a clinician can come to a broad understanding of

the patient in question for example a selection of scales might indicate that an individual is sleepy but not fatigued lacking alertness with no insomnia presenting with no symptoms of narcolepsy or restless legs but showing clear features of apnea exhibiting depression and a history of significant alcohol problems this information can be used to direct the consultation to those issues perceived as most relevant and can even provide a springboard for explaining the benefits of certain treatment approaches or the potential corollaries of allowing the status quo to continue second rating scales can provide a clinician with an enhanced vocabulary or language improving his or her understanding of each patient in the case of the sleep specialist a scale can help him to distinguish fatigue from sleepiness in a patient or elucidate the differences between sleepiness and alertness which is not merely the inverse of the former sleep scales are developed by researchers and clinicians who have spent years in their field carefully honing their preferred methods for assessing certain brain states or characteristic features of a condition thus scales provide clinicians with a repertoire of questions allowing them to draw upon the extensive experience of their colleagues when attempting to tease apart nuanced problems third some scales are helpful for tracking a patient s progress a particular patient may not remember how alert he felt on a series of different stimulant medications scale assessments administered periodically over the course of treatment provide an objective record of the intervention allowing the clinician to examine and possibly reassess her approach to the patient finally for individuals conducting a double blind crossover trial or a straightforward clinical practice audit those who are interested in research will find that their own clinics become a source of great discovery scales provide standardized measures that allow colleagues across cities and countries to coordinate their practices they enable the replication of previous studies and facilitate the organization and dissemination of new research in a way that is accessible and rapid as the emphasis placed on evidence based care grows a clinician s ability to assess his or her own practice and its relation to the wider medical community becomes invaluable scales make this kind of standardization possible just as they enable the research efforts that help to formulate those standards the majority of rating scales in sleep and sleep disorders 100 scales for clinical practice is devoted to briefly discussing individual scales when possible an example of the scale is provided so that readers may gain a sense of the instrument s content groundbreaking and the first of its kind to conceptualize and organize the essential scales used in sleep medicine rating scales in sleep and sleep disorders 100 scales for clinical practice is an invaluable resource for all clinicians and researchers interested in sleep disorders
