sweett group plc ordered to pay 2 2m in bribery case Feb 27 2024 the sweett group plc was ordered to pay a 1 4m fine a 851 152 confiscation amount and 95 000 in prosecution costs this case marks the first successful conviction of a s 7 offence in the

sweett group plc first conviction for bribery act corporate Jan 26 2024 summary today in southwark crown court sweett group plc was ordered to pay approximately 2 35m for the offence of failing to prevent bribery by an associated person under section 7 of the bribery act 2010 this case marks the first conviction of a corporate for that offence and offers the first real insight into how the court and prosecutor
