criminal prosecutions *Dec 24 2023*

the sixth amendment applies in criminal prosecutions only those acts that congress has forbidden with penalties for disobedience of its command are crimes 9 actions to recover penalties imposed by act of congress generally but not invariably have been held not to be criminal prosecutions 10

the sixth amendment rights of the accused findlaw Nov 23 2023

adopted in 1791 as part of the constitution s bill of rights the sixth amendment addresses important issues relating to criminal law it grants several rights to those facing criminal charges including the right to an attorney and the right to a trial by jury

sixth amendment right to be informed of criminal charges *Oct 22 2023*

the court explains that the sixth amendment right to be informed has two purposes 1 for the defendant to be able to defend himself or herself against specific charges and 2 for the court to know if there is enough evidence to convict the defendant
