WE RECOMMEND THE FOLLOWING BEST PRACTICES FOR CHURCH BENEVOLENCE PROGRAMS CREATE AND IMPLEMENT A WRITTEN POLICY DEFINE WHAT TYPES OF CONTRIBUTIONS WILL BE ALLOWED TO BE TAX DEDUCTIBLE CONTRIBUTIONS MUST BE MADE TO THE PROGRAM NOT TO A SPECIFIC INDIVIDUAL OR FAMILY APPOINT A COMMITTEE OR PERSONNEL TO REVIEW AND APPROVE REQUESTS
